___ Proposed Bylaws and Parliamentary Procedures of the Libertarian Party of the City of Phoenix, AZ (PXCityAZ) (1/30/2021)

___ The name of this Party shall be the Libertarian Party of the City of Phoenix, AZ (PXCityAZ).

___ The object of this Party shall be to elect Libertarians to public office.

___ The Membership of the Party shall be all members of the Libertarian Party of Arizona who reside in the City Phoenix, AZ, or who choose to affiliate with the Libertarian Party of Arizona within the City of Phoenix.

___ PXCITYAZ shall always use ranked choice voting (RCV) in the form of ranked paper ballots only (and eballots when practical and verifiable). Consecutive numbers beginning with the #s 1, 2, 3, 4, etc. etc. must always be used when marking on (e)ballot of all alternative decisions or names. Deviation from this guideline will disqualify the ballot, and the ballot will be marked spoiled.

___ For electing names, the single-transferrable vote (STV) is used, like in Cambridge Massachusetts City Council Election statutes.

___ Resignations and death would end the person's term and the next highest-ranked name, based on the original stack of paper ballots cast and kept as proof, is always automatically elected.

___ When the Droop Quota is used, all seats are elected at-large simultaneously within one at-large district.

Droop Quota = $(\text{Total Votes} / \text{Total Seats} + 1) + 1$

___ Names of up to 100 city-level-members shall be elected by ballot to serve for one year or until their successors are elected, and their term of office shall begin at the close of the annual meeting at which they are elected.

___ Nominations shall be from the floor. Up to fifty elected names of the 100 may be dues-payers and up to fifty elected names may be non-dues-payers (free member).

___ Elected non-dues-payers who may sign as dues-payer later may only serve as free member through the next election.

___ Once up to 100 county-level-members have been elected, they may each cast a ballot for executive officers.

___ For electing the LPCityLA executives for day-to-day decisions, the top-ranked elected name picks the open executive officer seat first, followed by every consecutively-ranked elected name which follows, until all seats are picked.

___ The officers of the Party shall be Chair, Vice-Chair, Secretary, Treasurer, Regional Representatives and three Judicial Committee members.

___ For electing bylaws, planks and decision-items, RCV is used, but STV is not used.

___ All items on the ballot for decision-items which garner 50% (plus one vote) under ranked choice voting (RCV), are items considered approved.

___ In cases where there are two similar decision-items elected with conflicting traits, then the higher-ranked item cancels out the lower-ranked item of similar nature.
